SUBMISSION OF RESOLUTION FOR THE 22ND GENERAL ASSEMBLY (GA22)

Submission of resolution(s) to the RSPO Secretariat must be done **online** via the online form. All resolutions must be completed and submitted before **27 August 2025, at 5:00 PM (GMT+8)**. Please note that a strict policy will be enforced and the online form will be closed at **5:00 PM (GMT+8)**. Late submissions WILL NOT be considered.

STRUCTURE OF RESOLUTIONS

The online form consists of the following structure and guidance to fill in each of the sections are provided below.

1 Title: Insert title of the resolution

3 Background

- (a)** Start with an introduction possibly with an inclusive statement that most members can agree on.
- (b)** State your objective for the resolution.
- (c)** If needed, define key terms of the resolution (For example, members with oil palm plantation operations will cover other sectors that own and manage oil palm plantations other than grower members).
- (d)** Identify problem statements based on the following:
 - (i)** Identify requirements or resolutions that already exists. Identify what problems still exist since the passing of the aforementioned resolutions and/or implementation of the requirements. Try to determine to what extent the targeted problems have been solved. Identify what changes and/or improvement have occurred since the implementation of the resolution and/or requirements, or
 - (ii)** Identify new problems that are not related to the above (ii), or
 - (iii)** Identify administrative changes that are required to ensure key documents (e.g. Statutes, Code of Conduct, etc) are up to date.

- b) Include a time frame for implementation.

- d) Identify/state the stakeholders (e.g. Board of Governors, members, secretariat and etc) addressed by the resolution.

5 Potential benefits

- a) Identify/state potential benefits in adopting and implementing the resolution.

6 Potential risks and mitigation

- a) Identify/state potential risk(s) in adopting and implementing the resolution.
- b) Identify/state how the above potential risk(s) can be mitigated.

7 Proposed Committee/Working Group/Task Force in overseeing the Resolution

Determine which committee/working group/task force is responsible for overseeing the implementation of the resolution.
